~ GUIDELINES ~

Please read the guidelines prior to completing and submitting the form

ELIGIBILITY:

- 1. Applicants must currently represent Wales and/or Great Britain as an amateur (unpaid) individual in one of the following
 - a. The National team or squad of a sport that is recognised by Sport Wales
 - b. A Welsh Schools or College Association Team that is acknowledged and recognised by the National Governing Body (NGB) of that Sport
 - c. As a referee/umpire selected by the National Governing Body limited to those that require a high level of fitness in order to carry out role
- 2. Applicants must meet at least one of the following criteria
 - a. reside in Carmarthenshire
 - b. attend a school in Carmarthenshire
 - c. is a member of a Sports Club in Carmarthenshire, providing financial assistance is not available from applicant's County of residence

TERMS AND CONDITIONS:

- 1. Only sports and the National Governing Body recognised by Sport Wales will be eligible. Please refer to the Eligible Sports leaflet for further details.
- 2. Applications must be accompanied by a selection letter or email from the recognised National Governing Body of the sport. This letter/email must
 - a. Clearly state that the athlete has been selected to represent Wales / Great Britain within the last 6 months.
 - b. Be on the official National Governing Body letter headed paper (emails/letters on non NGB headed paper will NOT be accepted)
 - c. Be signed by the relevant NGB Officer. (Emails will only be accepted if from a NGB email account, e.g. gmail, hotmail accounts will not be accepted)
- 3. Access to the facilities requested are subject to being relevant to your training needs therefore there is no guarantee that the 2 activities will be approved. Please see table below for list of activities available at each centre.
- 4. The Local Authority reserves the right to consult the National Governing Body in connection with the application in order to seek further clarification, assess the applicant's progress and current competitive status.
- 5. You will be notified via email or phone (if no email address provided) within a month of submitting the application of the outcome of your application.
- 6. If the relevant criteria are met and you are successful an Actif Card will be given
 - a. The successful applicant is the only one who can use the card.
 - b. The card is non-transferable.
 - c. The cardholder must comply with the rules and regulations for the facilities being used.
 - d. The Actif Card must be swiped every time, or the applicant will have to pay the full charge.
 - e. The card is valid for 12 months from date of issue; you will need to re-apply for a further 12 months if still eligible.

- 7. If successful you will be required to participate in future Sport & Leisure promotions that would be held throughout the year. This could include events/festivals for schools and Leisure Centres, courses and relevant marketing campaigns. Information will be emailed to you with information as and when necessary.
- 8. If the card is misused, the Local Authority reserves the right to withdraw the Gold Card status.
- 9. The Local Authority reserves the right to refuse to give a Carmarthenshire Actif Gold Card.
