THE COUNTY OF CARMARTHENSHIRE (OFF STREET PARKING PLACES) CONSOLIDATION (VARIATION NO 1) ORDER 2015

The Carmarthenshire County Council in exercise of their powers under Sections 35(1) and (3) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") as amended by the Parking Act 1989 and by the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act of 1984 hereby make the following Order:

- 1. The County of Carmarthenshire (Off Street Parking Places) Consolidation Order 2014 ("the Consolidation Order") shall be hereby varied and shall have effect as though:
- 1.1 For Article 16 there was substituted the following Article:

Subject to the provisions of Article 16A a parking ticket used in a Parking Place indicated in Schedule 2 of this Order shall only be a valid parking ticket if:

- (i) it has been purchased from a ticket machine in the parking place where the vehicle is left
- (ii) it is exhibited on the vehicle in a Relevant Position; AND
- (iii) it has been purchased in accordance with the provisions that in the Parking Places specified in Schedule 2 of this Order, one ticket per vehicle shall be valid either:
 - (a) for the number of hours or for the period specified on the ticket commencing, if purchased during Charging Hours, at the time of purchase or if purchased outside Charging Hours, at the beginning of the next following period of Charging Hours; OR
 - (b) from the time of purchase or if purchased outside Charging Hours from the beginning of the next following period of Charging Hours to the expiry time specified on the Ticket so however that no such ticket shall be valid after the vehicle has exceeded in any one period of Charging Hours the maximum period of waiting (if any) specified in Article 9 hereof, and
- 1.2 There shall be included an additional Article 16A:

The following exceptions shall apply to the provisions of Article 16(i):

(i) a ticket purchased from a Ticket Machine located in any of the short stay car parks situated in the towns of Ammanford, Llandeilo, Llandovery and Newcastle Emlyn shall be during the permitted hours or period described in Article 16(iii) be transferrable between each and every car park located in the said towns

- (ii) a ticket purchased from a Ticket Machine located in any of the short stay car parks situated in the town of Carmarthen shall be during the permitted hours or period described in Article 16(iii) shall be transferrable between each and every short stay car park located in the said town
- (ii) a ticket purchased from a Ticket Machine located in any of the short stay car parks situated in the town of Llanelli shall be during the permitted hours or period described in Article 16(iii) shall be transferrable between each and every short stay car park located in the said town
- (iv) a ticket purchased from a Ticket Machine located in any of the long stay car parks situated in the towns of Ammanford, Llandeilo, Llandovery and Newcastle Emlyn (with the exception of Hall Street, Ammanford) shall be during the permitted hours or period described in Article 16(iii) be transferrable between each and every car park located in the said towns
- (v) a ticket purchased from a Ticket Machine located in any long stay car park situated in the town of Carmarthen (with the exception of Priory Street car park) shall be during the permitted hours or period described in Article 16(iii) shall be transferrable between each and every long stay car park located in the said towns
- (vi) a ticket purchased from a Ticket Machine located in any long stay car park situated in the town of Llanelli (with the exception of Edgar Street car park) shall be during the permitted hours or period described in Article 16(iii) shall be transferrable between each and every long stay car park located in the said town
- 2. The Order shall come into operation on the 1st day of April Two Thousand And Fifteen and may be cited as The County of Carmarthenshire (Off Street Parking Places) Consolidation (Variation No. 1) Order 2015.
