PLEASE NOTE – NEW CONDITIONS OF LICENCE

A Bond Payment will be required on application to indemnify the Authority against substandard workmanship. The bond will be based upon :

£30 per linear metre in verge £80/m in footway £100/m in carriageway.

A cash/cheque payment is the simplest method.

This fee will, depending upon depth, be released after 2 years if excavation is less than 1.5m deep or 3 years if over 1.5m deep. However, should the reinstatement works become defective within the warranty period, then the defect will need to be rectified and a further 12 month warranty period will be incurred.
