Definitions

'Street Works' means works of any of the following kinds executed in a street in pursuant of a statutory right or a Street Works Licence -

- a) placing apparatus, or
- b) inspecting, maintaining, adjusting, repairing, altering or renewing apparatus, changing the position of apparatus or removing it,

or works required for or incidental to any such works (including, in particular, breaking up or opening the street, or any sewer, drain or tunnel under it, or tunnelling or boring under the street).

'Apparatus' means any structure for the lodging therein of apparatus or for gaining access to apparatus. This applies to pipes, ducts, cables, chambers, covers and frames and other apparatus as well as overhead lines and cables and other apparatus on or above ground including interconnecting cabinets, etc. The description for an apparatus given above is not intended to be exhaustive or prescriptive.
