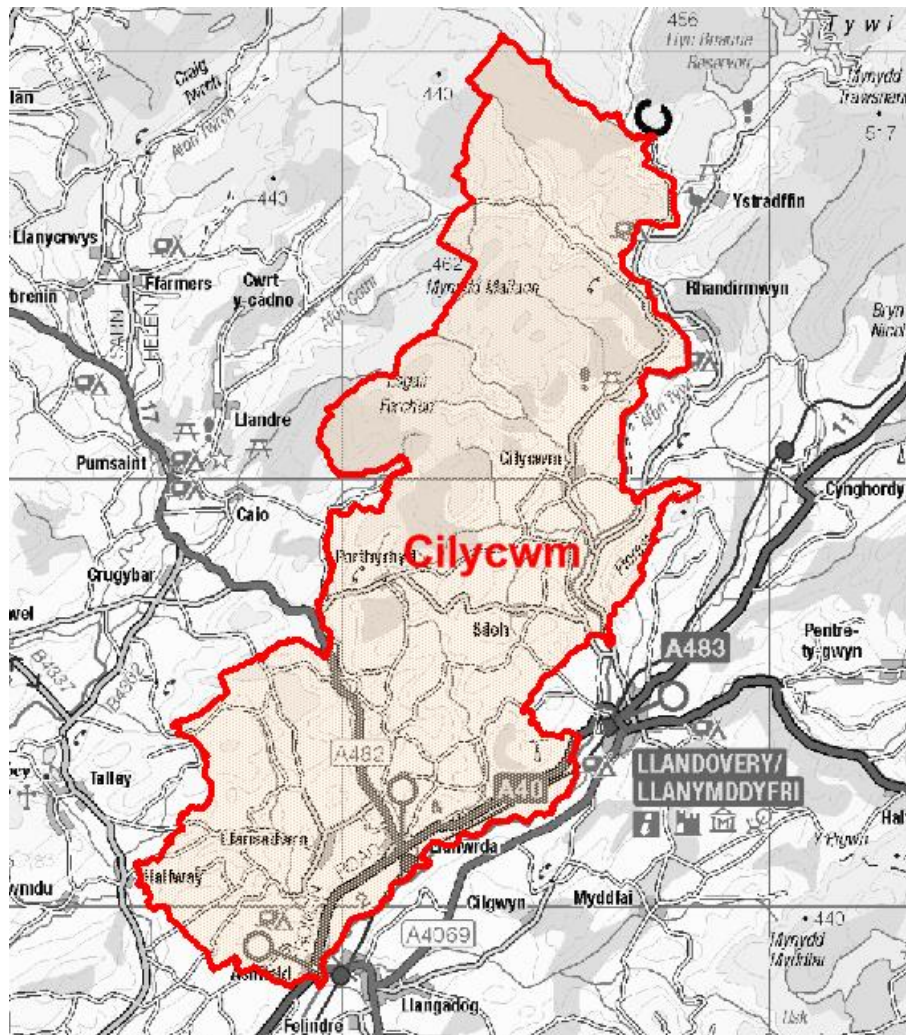

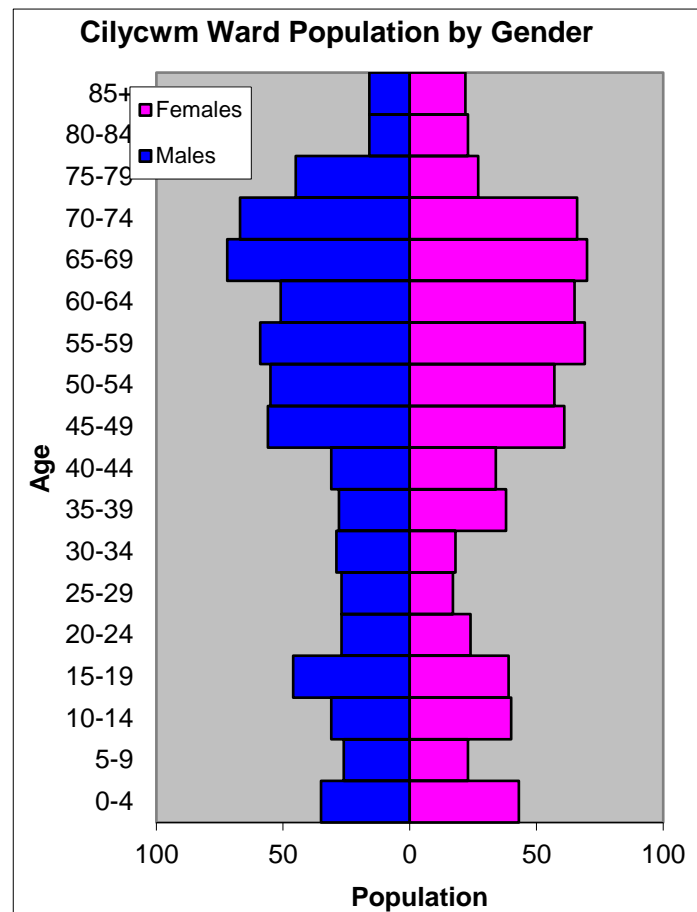

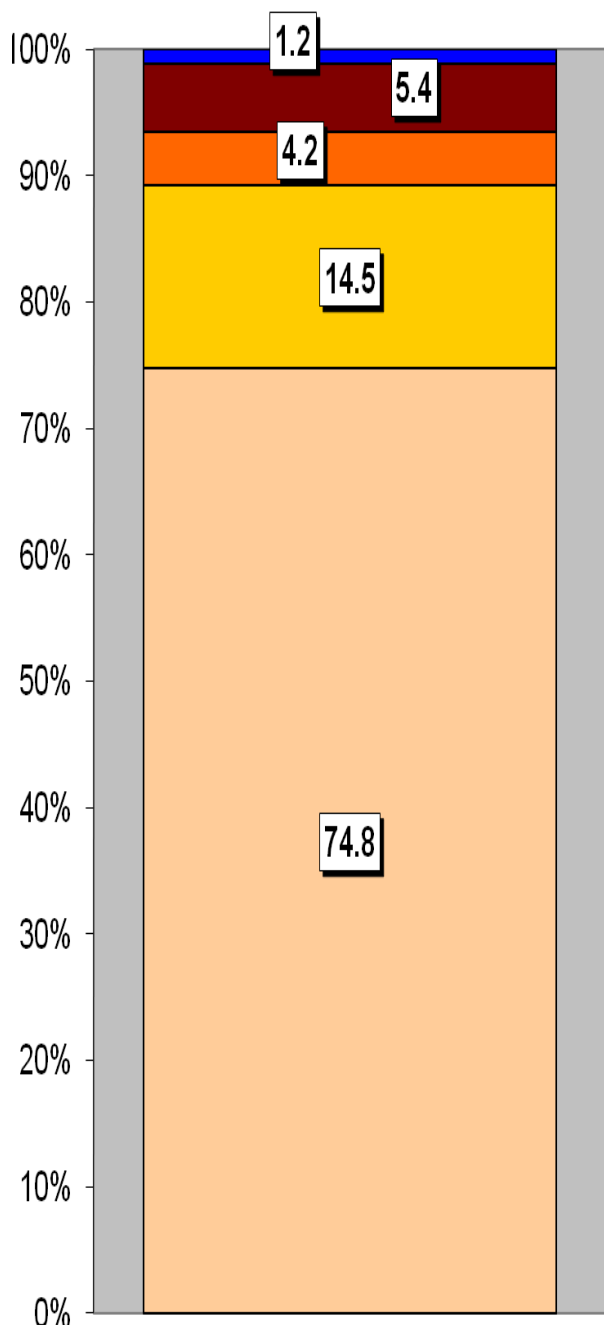

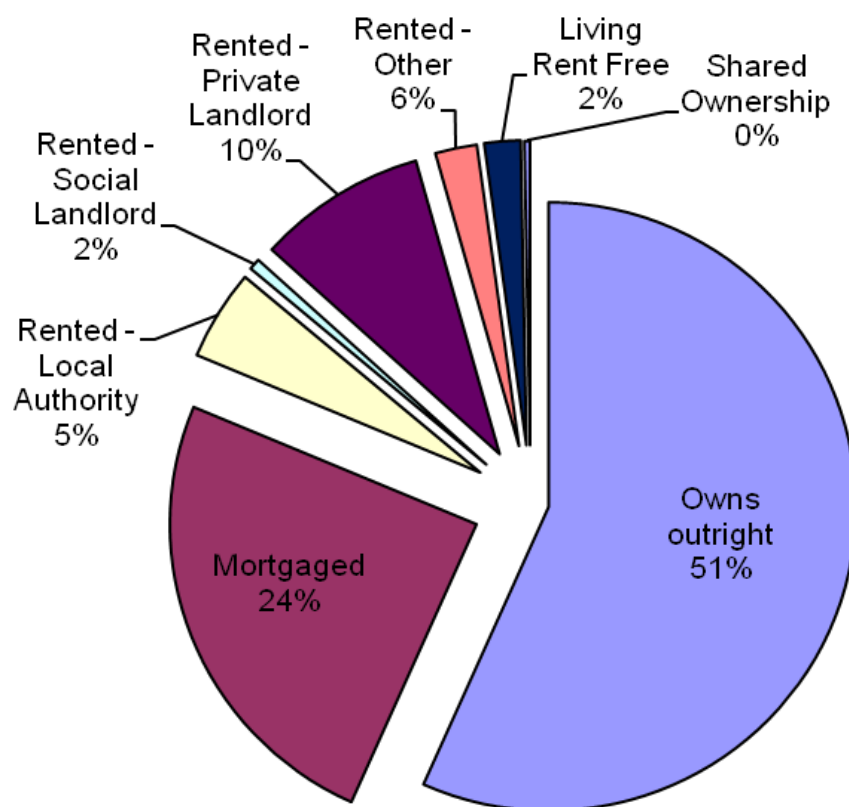
## HOUSING

The area's housing consists majorityly of detached houses, which is almost three quarters of the housing stock. This is followed by semi-detached, the terraced houses and flat, maisonette and apartment, have a very similar proportion. The ward consists of 30 local authority owned properties and 4 Housing Association properties.

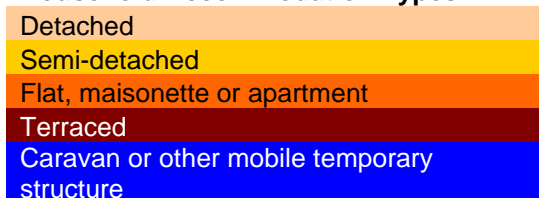

## SOCIO-ECONOMIC CHARACTERISTICS

- ⇒ The estimated median household income for Cilycwm, based on CACI's 2019 'PayCheck' data, is £29,528 which is the 18<sup>th</sup> highest (of 58 wards) in Carmarthenshire and 8.1% above the Carmarthenshire median of £27,148.
- ⇒ The social profile information indicates a lower than average level of who have never worked and long term unemployed (Level 8) and a higher than average number of small employers and own account workers (Level 4).

## WELSH INDEX OF MULTIPLE DEPRIVATION (WIMD)

WIMD 2019 based on fine-grained geography of lower Super Output Areas (LSOAs). The WIMD 2019 is compiled from eight domains, Income, Employment, Health, Education, Housing, Access to Services, Physical Environment and Community Safety and is published at Lower Super Output Area of which there are 112 in Carmarthenshire.

Under WIMD, where Rank 1 is the most deprived, **Cilycwm** ranks 58 out of 112 in Carmarthenshire and is ranked 910 in Wales from 1909 LSOAs.

The highest level of deprivation attributed to **Cilycwm** is the Housing domain, being ranked 5<sup>th</sup> in Carmarthenshire and 75 in Wales for this domain.
