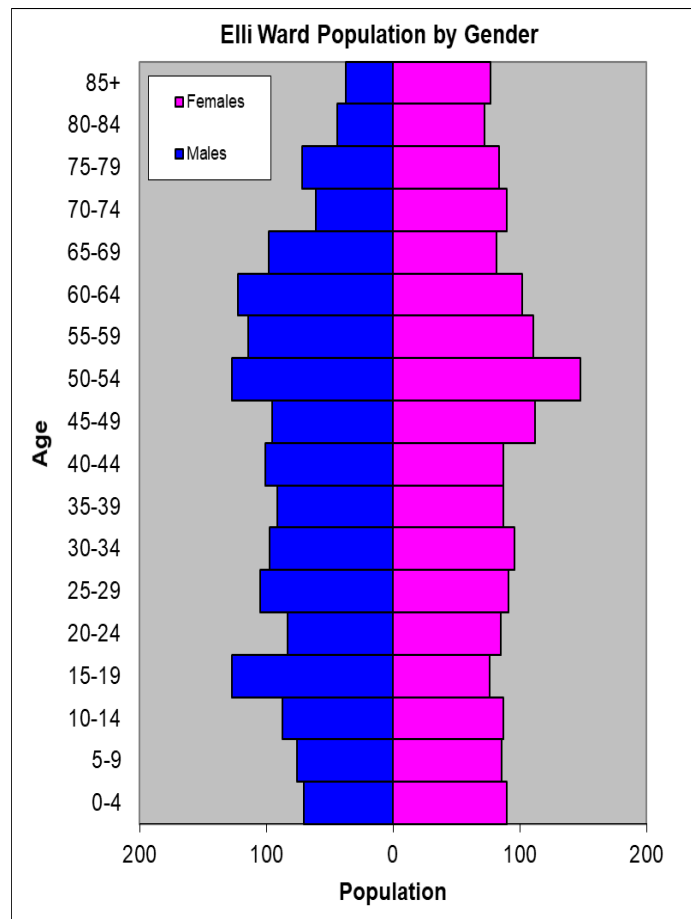

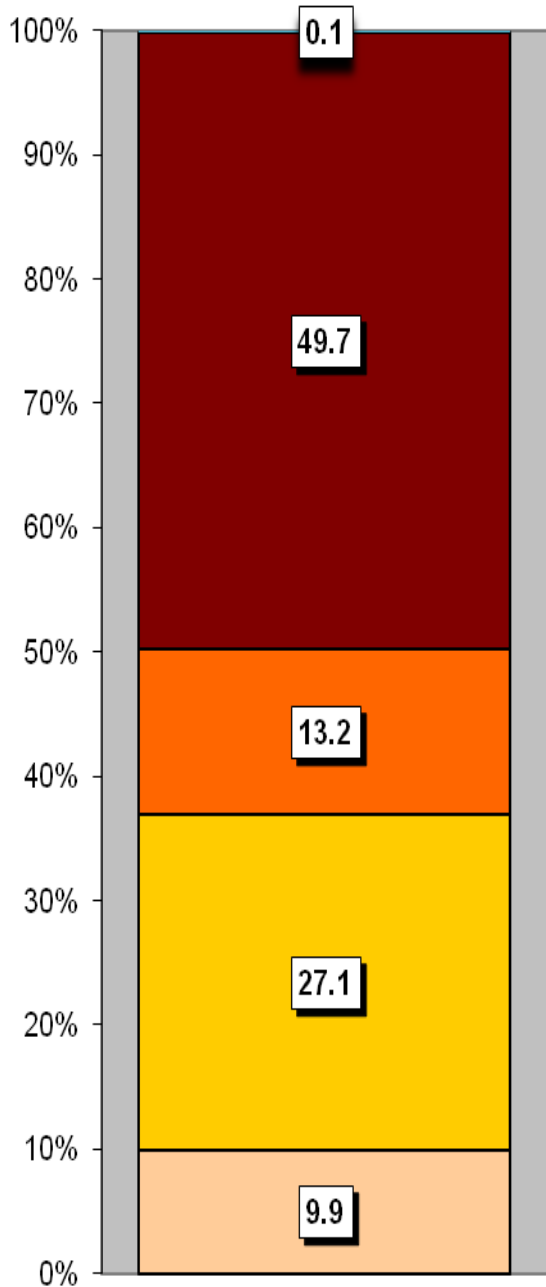

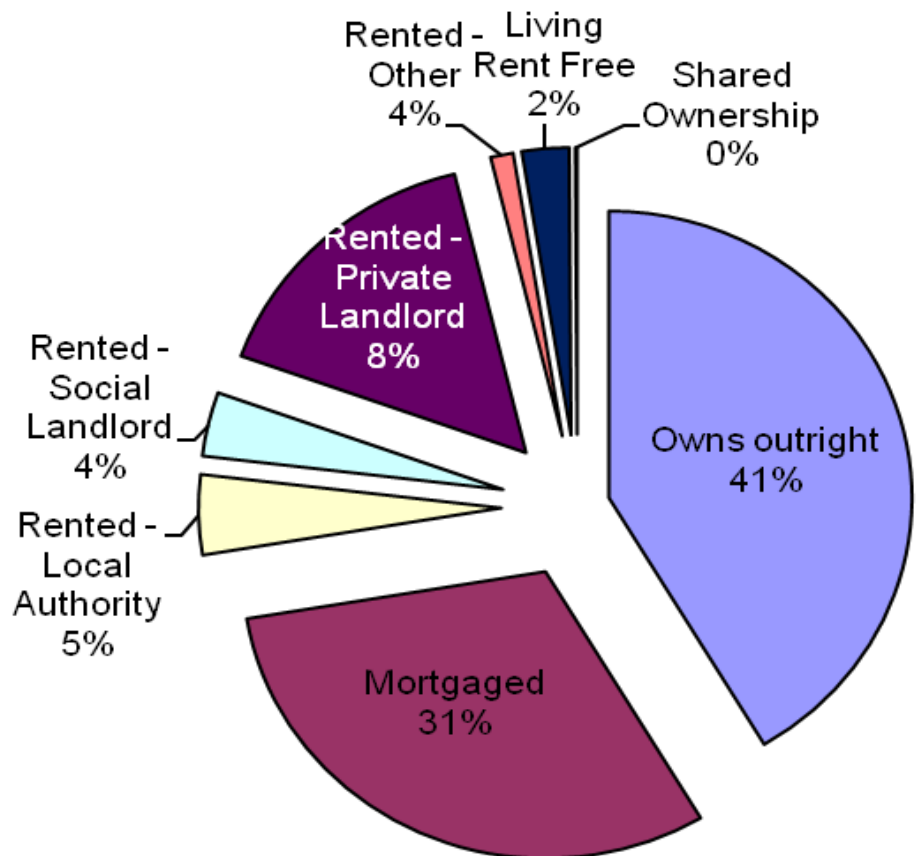
HOUSING

The area's housing consists mostly of terraced houses, which makes up just under half the housing stock. The ward consists of 65 local authority owned properties and 52 Housing Association properties.

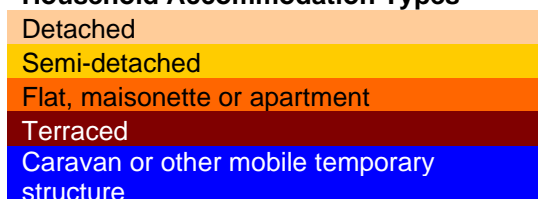

SOCIO-ECONOMIC CHARACTERISTICS

- ⇒ The estimated median household income for Elli, based on CACI's 2019 'PayCheck' data, is £26,161 which is the 19th lowest (of 58 wards) in Carmarthenshire and 3.8% below the Carmarthenshire median of £27,148.
- ⇒ The social profile information indicates a higher than average level of people in intermediate occupations (Level 3) and a higher proportion of people who have never worked or are long term unemployed (Level 8).

WELSH INDEX OF MULTIPLE DEPRIVATION (WIMD)

WIMD 2019 based on fine-grained geography of lower Super Output Areas (LSOAs). The WIMD 2019 is compiled from eight domains, Income, Employment, Health, Education, Housing, Access to Services, Physical Environment and Community Safety and is published at Lower Super Output Area of which there are 112 in Carmarthenshire. Under WIMD, where Rank 1 is the most deprived, **Elli 1** ranks 77 out of 112 LSOAs in Carmarthenshire and is ranked 1144 in Wales from 1909 LSOAs, whilst **Elli 2** ranks 20 out of 112 LSOAs in Carmarthenshire and 478 from 1909 in Wales.

The highest level of deprivation attributed to **Elli 1** is the Community Safety domain, being ranked 13th in Carmarthenshire and 349 in Wales for this domain. In **Elli 2** it is also the Community Safety domain that is the most prominent ranking 3rd in Carmarthenshire and 30 in Wales.
