Foreword to the Annual Report 2018

2018 has been an important year for the Carmarthenshire Local Access Forum (LAF) with the election of 12 members to the new LAF in June, along with two further members joining during the year, which means the LAF is currently made up of 14 individuals with varying interests and knowledge relating to access to the Countryside. This LAF will be in place for the next 3 years until June 2021.

I would like to thank previous members who decided not to stand for the new LAF for the time they put into the previous LAF.

The LAF has continued to make progress with increased awareness of what the LAF does and more input from various departments within Carmarthenshire County Council (CCC) and the Heads of Service.

Throughout 2018 CCC has continued work on its Rights of Way Improvement Plan (ROWIP) and it is hoped that this will be in place during 2019.

The LAF discussed 39 different topics during 2018 on a wide range of issues as outlined on pages 5 to 13. This shows that the LAF has been involved in looking at, discussing and advising on a significant number of items throughout the year.

CCC rights of way Maintenance and Legal teams have been working hard throughout 2018 to try to reduce the numbers of problems / issues on the network and it is concerning to see that that the number of outstanding maintenance issues has risen by 9% and that the number of legal issues has risen by 25% (between December 2017 and December 2018). The number of legal issues gives particular concern since it has risen by nearly 50% over the past couple of years. It is unclear whether these increases are due to improved reporting of problems / issues or the continued budget cuts faced by CCC. It was noted that the percentage of Public Rights of Way which are Open, Accessible and Signed declined slightly, to 45.9%. The LAF will continue to monitor the state of the rights of way network closely throughout 2019.

2019 will be another busy year for the LAF with the implementation of the ROWIP, the continued interest in the Tywi Valley Path project and continued discussions with the Heads of Service on strategic and policy issues relating to access to the countryside.

I would like to thank Caroline Ferguson, Lucy Pugh, Jason Lawday, Martin Murray and all members of the Rights of Way Team for the time they have spent and advice that has been given to the forum as secretaries / advisors over the past year.

I would also like to thank all forum members for the time and expertise they give to the forum.

A Note from the Secretary

The Carmarthenshire LAF has had another busy year. Alongside regular quarterly meetings where a wide variety of access related topics are discussed, the LAF have continued to assist and advise on the development of the Carmarthenshire ROWIP and have been through the dissolution of one LAF and election of new forum partway through the calendar year.

Members of the LAF have identified and discussed relevant access topics throughout 2018 which have an impact on access provision in Carmarthenshire. Valuable comments, strategic advice and/or guidance have then been fed back to the Local Authority, Natural Resources Wales (NRW) and any other access providers or users in the County.

The continuing provision of data from the Countryside Access service has helped forum members maintain an informed picture of both the operational challenge of keeping the public rights of way network open and an indication of the overall condition of the Public Rights of Way network. With this information the forum have been able to deliver appropriate and useful recommendations the service and the Authority as a whole.

A year of potentially significant changes to public access provision in Wales lies ahead. It is hoped that the Carmarthenshire LAF can continue to keep abreast of the changes and deliver valuable strategic advice to the Local Authority and the Welsh Government during the various stages of those changes.

I would like to express my thanks as interim Secretary for the commitment of the Carmarthenshire LAF membership and the knowledge, experience and constructive advice each member brings to the forum.

Introduction

The Carmarthenshire LAF was established in September 2002, and covers the County of Carmarthenshire, excluding the area of the Brecon Beacons National Park Authority for which their LAF has responsibility as shown in Appendix 3. The Local Authority had a statutory duty to establish the LAF as required by the Countryside & Rights of Way Act 2000.

The statutory function of the Forum is to advise the authority, Natural Resources Wales and others as to the improvement of public access to land in the area for the purpose of open-air recreation and the enjoyment of the area, with regards to the needs of land-management and the natural beauty of the area.

The remit of the Forum is now widened to advise not only the appointing authority (in our case Carmarthenshire County Council), the Highway Authority and other bodies as may be prescribed by regulations but to advise on the Public Rights of Way Improvement Plans, Wardening, the making of bylaws and long-term exclusions and restrictions on access.

The views of the Forum should be sought on any new regulations under the Countryside and Rights of Way Act 2000, the management of the new rights of access, the strategic priorities for the public rights of way and cycle networks and all other forms of open-air recreation.

Forum members are committed to attend outside groups if appropriate and are encouraged to do all they can to engage with the public.

All meetings of the LAF are open to the public. Minutes of meetings and other LAF details are available on the Carmarthenshire County Council website at: https://www.carmarthenshire.gov.wales/home/council-services/public-rights-of-way/local-access-forum

The National Assembly for Wales regulations requires appointing authorities to prepare an annual report for each LAF for which it is responsible as soon as possible after the end of the financial year. This report incorporates Natural Resources Wales' guidance on the production and content of Local Access Forum Annual Reports.

The annual report will serve several purposes:

- a) A summary record of the previous year's work. Minutes of individual meetings and other documents produced will give greater detail, but the annual report will summarise the LAF's work.
- b) A work plan for the coming year. This will be the plan agreed between the LAF and the appointing authority, in accordance with regulation 16(2)(b). It is acknowledged that changing priorities and pressure of other work may prevent the plan being adhered to in full.

c) A 'publicity' document. The annual report must, by statute, be made available for public inspection and it must be available for the public to buy.

The Year Reviewed

Reporting of the Statutory Function

This section of the annual report focuses upon the LAF's performance of its statutory function during the year ending 31st December 2018. This function, as included in the Countryside & Rights of Way Act 2000 is to advise:

- a) The appointing authority.
- b) Any body exercising functions under part I in relation to land in that area.
- c) If the appointing authority is a National Park Authority, the local highway authority for any part of that land, and
- d) Such other bodies as may be prescribed.

As to the improvement of public access to land in that area for the purposes of open-air recreation and enjoyment of the area.

The bodies mentioned in a) to d) above shall have regard, in carrying out their functions, to any relevant advice given to them by a LAF under this subsection or any other provision of this Act.

The LAF held 4 meetings in the period 1st January 2018 to 31st December 2018. These meetings can be summarised as follows:

Summary: The LAF has discussed the ROWIP at

several meetings and asked that it be fully consulted on the final report. Concerns were raised at the June meeting regarding the completeness of the consultation carried out. It was confirmed that this was being looked at again. At the September meeting it was confirmed that the draft was going to Exec board for approval on the 8th October and that a 12-week consultation will follow. At the December meeting it was confirmed that the Draft ROWIP had been approved by the Executive Board and that it had been received back from translation and that it would shortly be going out for consultation.

4. Topic Considered: Tywi Valley Path

Date(s) Considered: 15th February 2018, 14th June 2018

20th September 2018, 6th December 2018

Summary: The LAF expressed concerns with regards

to the project on several occasions, these concerns included the accuracy of the financial and user projections and allowing access to the route for equestrian users. It was agreed at the September meeting that the project and a lack of consultation with the LAF would be discussed at the Heads of

Service Meeting.

5. Topic Considered: **Brechfa Wind Farm**

20th September 2018

Summary: The LAF continued to keep an eye on the

project with regular updates. In the September meeting the issue of Public Liability Insurance was discussed and it was mentioned that the wind farm may cause insurance problems for some user groups, due to the proximity of the wind farm to some of the rights of way. It was agreed NRW would be asked for comment about

this.

6. Topic Considered: County Walks Review

Summary: Martin Murray informed the LAF that a

review of the County Walks is being

undertaken.

traffic regulation order for this Byway with CCC and was regularly kept up to date with

developments.

updates with regards to this area of land

and its ongoing access issues.

At the September meeting a map of

Bridleways was produced by CCC. At the December meeting Karen Burch (KB) confirmed that she had met with CCC to try to resolve some issues with regards to length of Bridleways shown in the ROWIP and that it would be difficult to fully resolve all of these issues. KB also asked if the report provided in February could show whether or not it would be possible to show

the issues on closed bridleways and whether it would be possible to re-open

them.

12. Topic Considered: Volunteering

Summary: The LAF has regularly been discussing the

use of volunteers to help CCC carry out simple maintenance tasks to the rights of way network. At the December meeting it

was confirmed that ramblers had been carrying out volunteer work on the rights of way network and that it would be good if this work could be recognised. There was also a discussion around payment of expenses for volunteers. It was agreed that a press release would be produced outlining the achievements of volunteers and that that the chair would discus expenses at the next heads of service meeting.

13. Topic Considered: BBNP Delegation Agreement

Summary: The LAF have been kept up to date with the

progress of the delegation agreement with

the Brecon Beacons National Park.

14. Topic Considered: Draft LAF Annual Report 2017

confirmed as ready for publishing at the February meeting. It was confirmed at the June meeting that the report was awaiting

translation.

the existing LAF would remain in place until

a new LAF was elected.

16. Topic Considered: Heads of Service Meeting

Summary: The LAF has been regularly kept up to date

with the heads of service meetings that the

LAF Chair and Vice Chair attend.

17. Topic Considered: Cambrian Mountains

Summary: At the February meeting the LAF were

informed that the Cambrian Mountains may be looking into 'Nature Park' status. The LAF was informed at the June meeting that a 'Tourist Map' of the Cambrian mountains

is in the process of being produced.

18. Topic Considered: Brechfa Mountain Bike Trails

Date(s) Considered: 15th February 2018, 14th June 2018

Summary: The LAF discussed the poor state of repair

of the mountain bike trails in Brechfa with NRW at the February meeting. NRW confirmed a spend of £40,000 along with usage statistics to the June meeting.

19. Topic Considered: Election of New LAF Membership

Summary: The new LAF was elected as shown in

Appendix 4. The LAF Chair and Vice Chair was also elected. At the September meeting Mo Rapley was accepted onto the LAF. At the December meeting Jim Shadbolt was

accepted on to the LAF.

20. Topic Considered: LAF Chairs Meeting

Summary: Following the June Chairs meeting the LAF

were updated with the topics discussed at the LAF Chairs meeting including use of performance indicators, what to do when a LAF term ends. LAF involvement in Glastir

and poor attendance of NRW representatives at LAF meetings.

BOAT/ORPA Subcommittee Update

Summary: The LAF discussed this topic on a number

of occasions and decided to carry out an initial investigation into the state of repair of the UCR and BOAT network. It was agreed

at the September meeting that a sub committee would meet on the 21st November to discuss BOAT's and UCR's and look at mapping the routes. At the December meeting it was confirmed that 2 meetings had been held to carry out a mapping exercise of the routes and that 79 routes had been highlighted as needing surveying. It was agreed that this would be discussed at the Heads of Service Meeting to see if this information would be useful to CCC.

progress of the Heart of Wales Line walking

trail.

to undertake some of the legal department's cases. At the December meeting members asked for an update on the Edwinsford Byway. It was confirmed that the consultant is still undertaking research. The LAF were informed that Finance Act maps and

informed that Finance Act maps and schedule books have been moved to

Haverfordwest. Councillor Hughes-Griffiths confirmed that the new archive building is progressing well and should open in

Autumn 2019.

Concerns had been raised that this may not be suitable as the track leading to the car park is very narrow and if it is full it would be difficult to turn

around with a trailer.






