Carmarthenshire Local Access Forum Annual Report 2020 Foreword to the Annual Report 2020

2020 has been an unusual year for the Carmarthenshire Local Access Forum (LAF) with only 3 meetings during the year. Only one of these was held in the normal manner before the first lockdown and the 2 others were held online following the Outbreak of the Coronavirus.

It has been a challenging year and one that I am sure we will all remember for the wrong reasons.

The Coronavirus pandemic has presented significant problems to everyone involved in providing public services including Carmarthenshire County Councils (CCC) rights of way team. Due to the lockdowns, travel restrictions and advice provided to the public this has led to more people staying at home and more people seeking to use their local rights of way network.

Although this has presented many challenges and generated significant work for the Councils teams it is positive to see more people using their local rights of way and beginning to appreciate what they have on their doorsteps. Hopefully, improved demand will lead to further improvements and prioritisation of these important assets for us all in the future.

It is also worth noting that throughout this 'challenging' year the rights of way team have continued to develop projects and worked through ideas that will ultimately lead to an improved rights of way network within the County.

As I write this report following the first of the 2021 online LAF meetings it is worth noting that significant steps have been made to bring to fruition several projects that will see a benefit to the network throughout 2021 and beyond.

It is hoped that further projects of this nature can be developed throughout 2021 and that the use of volunteers from all user groups can be used to further enhance the rights of way network within Carmarthenshire.

The LAF is currently made up of 13 members with varying interests and areas of expertise relating to rights of way and access to the countryside. It is hoped that this membership can be added to in 2021 when a new LAF will be elected for the following 3 years.

Jane Evans from the British Horse Society has stood down from the LAF during the year. I would like to thank Jane for being a member of the LAF and wish her well for the future.

The LAF is regularly attended by Steve Pilliner (Head of Highways and Transport for CCC) and Hazel Evans (Executive Board Member for Environment) along with representatives from Natural Resources Wales (NRW) and other members of the Rights of Way Team from CCC, and I would personally like to thank all these people for attending the LAF meetings and for the input you provide to the meetings.

The LAF discussed 20 different topics during 2020 on a wide range of issues as outlined on pages 6 to 10. This shows that the LAF has been involved in looking at, discussing and advising on a large number of items throughout the year.

Throughout 2020 the LAF has continued to monitor the number of outstanding legal and maintenance issues registered on the rights of way network. Unfortunately, the number of issues has increased steadily throughout the year. It is possible that this is due to the pressures presented by the Pandemic and the increased use of the network that has resulted from the restrictions placed on the public. It is hoped that the projects mentioned earlier, which are scheduled to take place throughout 2021 will start to make inroads into these issues and help to

reduce the numbers. The LAF will continue to monitor the situation and is hopeful of a more positive outcome by the end of 2021.

The LAF will continue to monitor the state of the rights of way network closely throughout 2021 with reports being presented to each meeting.

2021 will be another interesting year for the LAF with the continued monitoring of the ROWIP, the continued interest in the Tywi Valley Path project, working alongside CCC to develop an equestrian strategy for the county and continued discussions with the Heads of Service on strategic and policy issues relating to access to the countryside.

I would like to thank Caroline Ferguson and all members of the Rights of Way Team for the time they have spent and advice that has been given to the forum as secretary / advisors over the past year.

I would also like to thank all forum members for the time and expertise they give to the forum.

Introduction

The Carmarthenshire LAF was established in September 2002, and covers the County of Carmarthenshire, excluding the area of the Brecon Beacons National Park Authority for which their LAF has responsibility as shown in Appendix 3. The Local Authority had a statutory duty to establish the LAF as required by the Countryside & Rights of Way Act 2000.

The statutory function of the Forum is to advise the authority, Natural Resources Wales and others as to the improvement of public access to land in the area for the purpose of open-air recreation and the enjoyment of the area, with regards to the needs of land-management and the natural beauty of the area.

The remit of the Forum is now widened to advise not only the appointing authority (in our case Carmarthenshire County Council), the Highway Authority and other bodies as may be prescribed by regulations but to advise on the Public Rights of Way Improvement Plans, Wardening, the making of bylaws and long-term exclusions and restrictions on access.

The views of the Forum should be sought on any new regulations under the Countryside and Rights of Way Act 2000, the management of the new rights of access, the strategic priorities for the public rights of way and cycle networks and all other forms of open-air recreation.

Forum members are committed to attend outside groups if appropriate and are encouraged to do all they can to engage with the public.

All meetings of the LAF are open to the public. Minutes of meetings and other LAF details are available on the Carmarthenshire County Council website at: https://www.carmarthenshire.gov.wales/home/council-services/public-rights-of-way/local-access-forum/#.XIPZRWdFCP8

The National Assembly for Wales regulations requires appointing authorities to prepare an annual report for each LAF for which it is responsible as soon as possible after the end of the financial year. This report incorporates Natural Resources Wales' guidance on the production and content of Local Access Forum Annual Reports.

The annual report will serve several purposes:

- A summary record of the previous year's work. Minutes of individual meetings and other documents produced will give greater detail, but the annual report will summarise the LAF's work.
- b) A work plan for the coming year. This will be the plan agreed between the LAF and the appointing authority, in accordance with regulation 16(2)(b). It is acknowledged that changing priorities and pressure of other work may prevent the plan being adhered to in full.
- c) A 'publicity' document. The annual report must, by statute, be made available for public inspection and it must be available for the public to buy.

<u>The Year Reviewed</u>

Reporting of the Statutory Function

This section of the annual report focuses upon the LAF's performance of its statutory function during the year ending 31st December 2020. This function, as included in the Countryside & Rights of Way Act 2000 is to advise:

- a) The appointing authority.
- b) Any body exercising functions under part I in relation to land in that area.
- c) If the appointing authority is a National Park Authority, the local highway authority for any part of that land, and
- d) Such other bodies as may be prescribed.

As to the improvement of public access to land in that area for the purposes of open-air recreation and enjoyment of the area.

The bodies mentioned in a) to d) above shall have regard, in carrying out their functions, to any relevant advice given to them by a LAF under this subsection or any other provision of this Act.

The LAF held 3 meetings in the period 1st January 2020 to 31st December 2020. These meetings can be summarised as follows:

1.	Topic Considered:	New Members / Resignations
	Date(s) Considered:	12 th March 2020, 22 nd October 2020
	Summary:	Paul Barrett resigned from the LAF at this meeting (this resignation was subsequently withdrawn and Paul continues as a member of the LAF). Clive Poulton from Carmarthenshire Disability Group attended the meeting to discuss joining the LAF (To date Clive has not joined the LAF). Jane Evans resigned from the LAF at the October meeting.
2.	Topic Considered:	National Cycle Network Barrier Removal
	Date(s) Considered:	12 th March 2020
	Summary:	It was confirmed that a number of barriers have been removed from the National Cycle Network and this does not appear to have led to a significant issue of motorbike usage, which had been a concern expressed with regards to their removal.
3.	Topic Considered:	Brechfa Windfarm Public Liability / Brechfa Windfarm
	Date(s) Considered:	12 th March 2020
	Summary:	It was confirmed that users of Brechfa Forest were still awaiting confirmation from NRW regarding public liability insurance. Phil Morgan from NRW was to discuss this with Jillie Gardiner. It was discussed under AOB in the March meeting that 2 permissive waymarked trails are being created in Brechfa West.
4.	Topic Considered:	Public Access Management in Leisure / Public Rights of Way Management
	Date(s) Considered:	12 th March 2020
	Summary:	A discussion was held regarding capital budgets for the year and the capital financing for the Tywi Valley Path. Stephen Pilliner also confirmed the need to use volunteers as much as possible to assist with the finances. It was confirmed that the Ash Dieback program would concentrate on main roads and not rights of way. There was also a discussion regarding active travel. It was also confirmed that the Tywi Valley Path project was still moving forward with ongoing landowner negotiations, planning and ecology surveys being undertaken.
5.	Topic Considered:	County Walks / Walking Promotion

	Summary:	A discussion was held regarding the County Walks programme and increased marketing of them by CCC during 2020 in the

Prior to the July meeting Martin Murray updated LAF members on the progress made and confirmed that the website had been updated and work was ongoing with the County Walks project. At the October meeting the idea of including which routes are suitable for disabled users was discussed. It was confirmed this would be taken back to the team for discussion.
6.	Topic Considered:	Access Reform
	Date(s) Considered:	12 th March 2020, 9 th July 2020, 22 nd October 2020
	Summary:	The LAF were updated on the access reform programme and informed that it would be consulted on the proposals at the March meeting. At the July meeting the complicated nature of the consultation was discussed and it was agreed that the LAF would comment that due to the nature and timing of the consultation it was difficult to provide constructive feedback at this time. At the October meeting it was confirmed that the 3 rd phase of the Access Reform had been completed and that feedback and comments from the expert groups has been fed into the process. More information will follow in 2021.

	Summary:	The LAF were informed that 141 rights of way signposts had been installed on the highway in the last 3 years.
8.	Topic Considered:	NRW Area Statements
	Date(s) Considered:	12 th March 2020
	Summary:	David Bleines from NRW discussed the area statements with the LAF.
9.	Topic Considered:	LAF Annual Report
	Date(s) Considered:	12 th March 2020
	Summary:	The LAF Annual report for 2019 was discussed with the LAF.
10.	Topic Considered:	Issue Reports
	Date(s) Considered:	12 th March 2020, 9 th July 2020, 22 nd October 2020
	Summary:	Quarterly reports on the number of outstanding issues for both legal and maintenance issues were received and discussed at each LAF meeting. Issue reports have been provided since May 2016, and since this time there has been an upwards trend for both Maintenance (+45%) and Legal (+110%) issues. This trend has continued and accelerated in both areas during 2020. The

reasons for this have been various, including: a significant increase in the number of issues being reported, probably because more members of the public have been wanting to use their local rights of way in 2020 due to lockdown restrictions; Legal Orders have been difficult to process due to contact centres being close for a significant part of the yea, and it has been more difficult for staff to get out to make site visits; Maintenance issues have also increased due to rangers being limited in what they are able to do due to travel and work restrictions. At the July meeting the idea of using volunteers to reduce the backlog was discussed. At the October meeting it was confirmed that the number of issues being reported had accelerated during the year. Councillor Hazel Evans commented that this is likely to be because the number of users on the network had increased due to people not being able to travel far and so were exploring their local neighbourhood instead, and that hopefully 2021 will see the use of more volunteers and Community Councils helping to keep the network open. Stephen Pilliner confirmed that having these figures from these regular reports helps Cyngor Sir Gar/Carmarthenshire County Council keep a focus on the health of the Public Rights of Way network and informs relevant strategic plans.

 Topic Considered:
 Update on Specific Issues Relating to Cardi Bach & Pontfelin Gat

Date(s) Considered: 12th March 2020, 9th July 2020

Members had requested an update regarding issues relating to these 2 projects. In the March meeting it was confirmed that a feasibility study was being looked at by a local group for a multi user route at Cardi Bach. It was confirmed that Pontfelin Gat had been closed by the National Botanic Gardens and that it may be subject to a claim of public rights. The feasibility study for Cardi Bach was also discussed at the July meeting.

Summary: It was confirmed at the March meeting that approval had been given for a 2-year fixed term assistant post plus the use of a consultant. At the October meeting it was confirmed that a new Countryside Access assistant was in place and that Caroline Ferguson has been confirmed in post as the Countryside Access Manager.

	Summary:	It was confirmed at the March meeting that the Equestrian Strategy for Carmarthenshire is scheduled to be available in draft in a year. It was confirmed in the October meeting that the formulation of the strategy had been delayed and was now planned for 2021.
15.	Topic Considered:	Affects of COVID 19 on the Rights of Way Team
	Date(s) Considered:	9 th July 2020, 22 nd October 2020
	Summary:	At the July meeting Caroline Ferguson updated the LAF on the negative impact the pandemic was having on the rights of way team and the way it operates and manages the rights of way. At the October meeting Stephen Pilliner outlined the problems being faced by the rights of way teams and explained that the maintenance team had only been able to respond to critical incidents with the legal team being inundated with landowner issues and obstruction complaints. Hazel Evans commented that this was due to a massive increase in the use of the network during lockdowns and that other services like waste collection had to be prioritised. Caroline Ferguson explained that CAMS was being developed to help organise and manage volunteers from next year and there were 4 rangers currently in post in the maintenance team.

	Summary:	The chair informed the LAF that he had attended an online meeting to discuss the project with CAPITA, Sustrans and Active Travel Wales members also being present. It was confirmed that CAPITA are re doing the feasibility study for the project and were asking businesses about the value of the project to them. It was explained that the chair thought that this study should have been undertaken before the project started.
