### **Conditions and scales of fees for the reproduction of archive material, and for filming on Archives Service premises.**

1. Reproduction of material in the custody of the Carmarthenshire Archives can normally be supplied at current charges (packing and postage extra). The Archives Transformation Manager, however, reserves the right to refuse permission for reproductions to be made without stating any reason; and some depositors have specified that they are not prepared to allow copies to be made, in which cases their wishes are, of course, scrupulously respected.
2. Copyright: Permission to reproduce a copy of any item does not obviate the need to obtain any necessary consent to the reproduction of any owner of any copyright in the item. Carmarthenshire Archives cannot give any information or offer any opinion on the existence of any copyright in any item. In consideration of permission to film or reproduce, the licensee must agree to assign any copyright created back to the Archives Service.
3. Acknowledgement of the source of a reproduction must be made in any publication or on any film or television programme in which it may appear. The form of acknowledgement should be 'COURTESY OF CARMARTHENSHIRE ARCHIVES (with the document REFERENCE NUMBER) unless otherwise agreed. The acknowledgement must appear (in publications) either in immediate proximity to the reproduction or in the section devoted to acknowledgements, where the item(s) in question must be identified. Acknowledgements in television programmes or films should be made among the credits, and with suitable prominence.
4. No copies may be made by any person of copies supplied by the Carmarthenshire Archives. No negatives are supplied. Copies are supplied solely for the purposes originally declared and are not to be subsequently placed in a picture library or otherwise re-used without permission.
5. Permission to reproduce and the fee payable cover only the specific occasion as specified. All reprints, further editions, or re-employment of the printing plates in another project require new applications and are not covered by the original fee.
6. A voucher copy of each and any publication or a copy of the television programme etc. in which items reproduced from the Carmarthenshire Archives collections appear must be forwarded to the service, in addition to the reproduction fee.

7. The right is reserved to refuse applications without specifying a reason.
