The Town and Country Planning Act 1990

Local Government (Miscellaneous Provisions) Act 1976

and

the Acquisition of Land Act 1981

The Carmarthenshire County Council (in this order called 'the acquiring authority') makes the following order —

- 1. Subject to the provisions of this order, the acquiring authority is, under section 226(1)(a) of the Town and Country Planning Act 1990 and section 13 of the Local Government (Miscellaneous Provisions) Act 1976, hereby authorised to purchase compulsorily the land and the new rights over land described in paragraph 2 for the purpose of
 - (i) Facilitating the development of land by the construction of a shared use route suitable to accommodate both pedestrians and cyclists which will extend in a westerly direction from Ffairfach, Llandeilo to Whitemill, a distance of approximately nineteen decimal point two two (19.22) kilometres, which route once constructed will contribute to the achievement of the promotion and improvement of the economic, social and environmental well-being of its area.
- 2. (1) The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked "Map referred to in The Carmarthenshire County Council (Ffairfach to Whitemill Shared Use Route) Compulsory Purchase Order 2023".
 - (2) The new rights to be purchased compulsorily over land under this order are described in the Schedule and the land is shown blue on the said map.
