- If you think our decision about a Discretionary Housing Payment is wrong.

- 2. you have received a reply and are still not happy with the decision

you can appeal directly to the Valuation Tribunal (details below).

For Housing Benefit disputes only - if your dispute is more than one month after the decision was made, please say why your appeal has been delayed and provide supporting evidence if available.

If you have any documents or letters in support of this request, from social workers, solicitors or

citizens advice bureau etc. please submit them with this form and tick here .

What happens when we look at our decision again?

The decision will be checked by a different officer to the one who made the original decision to see if it is correct.

If we change our decision:

- we may change it from the date of our original decision; and
- we will send you a letter explaining our new decision.

If the new decision is in your favour your appeal will lapse and you will be given new rights of appeal.

If we cannot change our decision:

- we will send you a letter explaining why; and
 - a) if your appeal relates to a Housing Benefit decision you have one more month to appeal to the Tribunals Service.
 - b) If your appeal relates to a Council Tax Reduction decision you have 2 months to appeal to the Valuation Tribunal from the date of our letter.

Withdrawing an appeal

You can withdraw your appeal at any time before a hearing but any notice of withdrawal must be received in writing by the local authority.
