ORDER UNDER SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847

FOR THE PREVENTION OF OBSTRUCTION

WHEREAS on Friday 27th February 2026 between the hours of 08:00 and 14:00, Guildhall Square in Carmarthen will be thronged and liable to be obstructed for schools' entertainment to celebrate St David's Day.

Carmarthenshire County Council, pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847, DOES HEREBY ORDER AND DIRECT that, for the purpose of preventing obstruction in the said street, Guildhall Square in Carmarthen shall be closed to all vehicular traffic (including pedal cycles) between the hours indicated above on Friday 27th February 2026 subject to emergency service vehicles being allowed access without delay in the event of an emergency.
