

THE COUNTY OF CARMARTHENSHIRE
(U5470 FELINDRE)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the U5470 Felindre, from a its junction with the C1296 Felindre, for a distance of 1.1km in a south easterly direction are satisfied that traffic in the said length of road should be restricted by reason of the works proposed to be executed thereon.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the U5470 Felindre, from a its junction with the C1296 Felindre, for a distance of 1.1km in a south easterly direction.
2. This Order shall come into operation on the Twenty Fourth day of September Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (U5470 Felindre) (Temporary Prohibition of Through Traffic) Order 2026.
