

THE COUNTY OF CARMARTHENSHIRE
(PART OF THE CLASS III ROAD LEADING FROM THE A482 PUMSAINT TO
CWRT-Y-CADNO)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of the Class III Road leading to Cwrt-Y-Cadno, commencing approximately 1.1km north-east of its junction with the A482 Pumsaint, for a distance of 240 metres in a north-easterly direction, are satisfied that traffic in the said length of road should be restricted by reason of the works proposed to be executed thereon.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Class III Road leading to Cwrt-Y-Cadno, commencing approximately 1.1km north-east of its junction with the A482 Pumsaint, for a distance of 240 metres in a north-easterly direction.
2. This Order shall come into operation on the Third day of November, Two Thousand and Twenty-Five and may be cited as The County of Carmarthenshire (Part of the Class III Road Leading from the A482 Pumsaint to Cwrt-Y-Cadno) (Temporary Prohibition of Through Traffic) Order 2025.

2. Bydd y Gorchymyn hwn yn dod i rym ar y 3ydd Tachwedd, Dwy Fil a Dau Ddeg Pump a gellir cyfeirio ato fel Gorchymyn Sir Gaerfyrddin (Rhan o'r Ffordd Dosbarth III sy'n Arwain o'r A482 Pumsaint i Gwertycadno) (Gwaharddiad Dros Dro ar Draffig Trwodd) 2025.
