

THE COUNTY OF CARMARTHENSHIRE
(B4314 PENDINE LEADING TO RED ROSES)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2025

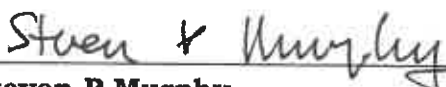
WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of the B4314 Pendine, from its junction with the Class III Road leading to Marros on the crossroads for a distance of 1.9km in a north-westerly direction, are satisfied that traffic in the said length of road should be restricted by reason of the works proposed to be executed thereon.

NOW therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the B4314 Pendine, from its junction with the Class III Road leading to Marros on the crossroads for a distance of 1.9km in a north-westerly direction.
2. This Order shall come into operation on the Seventeenth day of November, Two Thousand and Twenty-Five and may be cited as The County of Carmarthenshire (B4314 Pendine leading to Red Roses) (Temporary Prohibition of Through Traffic) Order 2025.

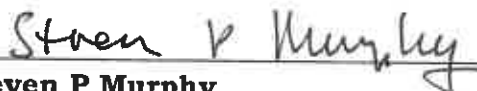
