

**THE COUNTY OF CARMARTHENSHIRE**  
**(C2209, HERBERDEG ROAD, PONTYATES (SA15 5UP))**  
**(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2026**

**WHEREAS** the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Road known as the C2209, Herberdeg Road, Pontyates from a point 210 metres Northwest of its junction with the C2209 for a distance of 712 metres in a North Westerly direction.

**NOW** therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers hereby make the following Order:-

1. No person shall cause any vehicle to proceed along that length of the Road known as the the C2209, Herberdeg Road, Pontyates from a point 210 metres Northwest of its junction with the C2209 for a distance of 712 metres in a North Westerly direction.
2. This Order shall come into operation on the Twelfth day of March Two Thousand and Twenty-Six and may be cited as The County of Carmarthenshire (the C2209, Herberdeg Road, Pontyates (SA15 5UP)) (Temporary Prohibition of Through Traffic) Order 2026.
