

THE COUNTY OF CARMARTHENSHIRE
(IMPOSITION OF 30 M.P.H. SPEED LIMIT) (No.2) ORDER 2024

The County Council of Carmarthenshire (hereinafter referred to as "the Council"), in exercise of its powers under Sections 84(1)(a), 84(1)(c), 84(2) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984 (as amended) ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as "The County of Carmarthenshire (Imposition of 30 m.p.h. Speed Limit) (No.2) Order 2024" and shall come into operation on the day of 2024.

2. In this Order:
 - (a) 'Map' means a map comprising the entire County of Carmarthenshire, which is to be read in conjunction with the Order and forms part of the Order;
 - (b) 'Map Tile' means a rectangle of a grid overlaying the Map denoting an area of the County of Carmarthenshire, with each tile having a unique Tile Reference;
 - (c) 'Tile Reference' means the reference given to each Map Tile, starting in the top left extremity and increments numerically across the grid horizontally and alphabetically down the grid vertically;
 - (d) 'Map Schedule' means the collection of Map Tiles listed in the Schedule to this Order showing, by reference to the Map Schedule Legend:
 - (i) the lengths of road subject to the speed limit imposed by this Order, and
 - (ii) the lengths of road (or parts thereof) ceasing to be subject to the provisions of the Order herein revoked;

- (e) 'Map Schedule Legend' means the Map Schedule Legend endorsed on the Map Tile, identifying:
 - (i) the lengths of road subject to the speed limit imposed by this Order, and
 - (ii) those lengths of road (or such parts thereof) ceasing to be subject to the restrictions imposed by the Order herein revoked;
 - (f) 'Exempted Vehicle' means:
 - (i) any vehicle being used for the purposes described in Section 87 of the Road Traffic Regulation Act 1984;
 - (ii) any vehicle being used for naval, military or air-force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the Special Forces in response or for practice in responding to a national security emergency by a person who has been trained in driving at high speeds or for the purpose of training a person in driving vehicles at high speeds;
 - (g) 'Special Forces' means those units of the armed forces, the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are, for the time being, subject to the operational command of the Director of Special Forces.
3. No person shall drive any motor vehicle, other than an Exempted Vehicle, at a speed exceeding 30 m.p.h. in the lengths of road shown on the Map Schedule specified in Schedule 1 to this Order.
4. 'The County of Carmarthenshire (Imposition of 30mph Speed Limit) Order 2023' and 'The County of Carmarthenshire (B4309 Cwmffrwd to Five Roads and the B4306 Cwmffrwd) (Imposition of 40 and 50mph Speed Limit) Order 2013' are hereby revoked insofar as they relate to the lengths of road identified on the Map Schedule specified in Schedule 2 to this Order.
