

**THE COUNTY OF CARMARTHENSHIRE**  
**(WITH THE EXCEPTION OF CARMARTHEN, LLANELLI AND AMMANFORD)**  
**(WAITING RESTRICTION AND STREET PARKING PLACES)**  
**CONSOLIDATION (VARIATION NUMBER 42) ORDER 2025**

The Carmarthenshire County Council, in exercise of their powers under Sections 1(1), 2(1) to 2(3), 4(2), 32, 35 and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as “the Act of 1984”) (as amended) and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The County of Carmarthenshire (with the exception of Carmarthen, Llanelli and Ammanford) (Waiting Restriction and Street Parking Places) Consolidation (Variation Number 42) Order 2025" and shall come into operation on the XXX day of XXX 2026.
2. In this Order:
  - a. The County of Carmarthenshire (County of Carmarthenshire with the exception of Carmarthen, Llanelli and Ammanford) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004' (“the Consolidation Order”), as subsequently varied, is hereby further varied as though the plans denoting Areas AA149, BQ143, BR143, BU213, BZ200, CC182, CD213, CD214, CF214, CN162, CN163, CT126, CU126, CY167, CZ163, DA164, DA165, DA173, DB173, DB174, DG155, DJ170, DJ171 and DR163 annexed thereto, were substituted with corresponding numbered plans attached to this Order.
  - b.
    - (i) The County of Carmarthenshire (with the exception of Carmarthen, Llanelli and Ammanford) Special Parking Area (Residents Parking Places) Order 2011;
    - (ii) The County of Carmarthenshire (County of Carmarthenshire with the exception of Carmarthen, Llanelli and Ammanford) (Waiting

Restriction and Street Parking Places) Consolidation (Variation No.22) Order 2015; and

- (iii) The County of Carmarthenshire (with the exception of Carmarthen, Llanelli and Ammanford) (Waiting Restriction and Street Parking Places) Consolidation (Variation Number 41) Order 2024,

are hereby revoked insofar as the same relate to the restrictions briefly described in Schedules 1, 2 and 3 to this Order and more particularly shown on the plans bearing the unique reference numbers specified in column 3 of the said Schedules.
