

# APPLICATION FOR THE GRANT OF A PRIVATE HIRE OPERATORS LICENCE

#### **GUIDANCE NOTES FOR PRIVATE HIRE OPERATORS LICENCE**

- 1. Please read carefully the attached Private Hire Operators Licence conditions.
- The application can either be submitted at one of the Council's Customer Service Centres at: - 41 Quay Street, Ammanford, SA18 3BS - Unit A, St Catherine's Walk, Carmarthen, SA31 1GA - 36 Stepney Street, Llanelli, SA15 3TR Or by post to: Department for Communities, Carmarthenshire County Council, 3 Spilman Street, Carmarthen, SA31 1LE

The application must be accompanied by the Appropriate Licence fee:

- 1 Year Licence £162.00 then on renewal each year £152.00 or
- 5 Year Licence £708.00 then on renewal every 5 years £698.00

Please note: - If you are not currently a Licensed Driver with this Authority your right to work in the UK will be checked as part of your licensing application, this could include the licensing authority checking your immigration status with the Home Office.

You must therefore provide a document or document combination that is stipulated as being suitable for this check. The list of documents is attached as Annex A. You must bring the original document(s), such as a passport or biometric residence permit as indicated in Annex A, so that the check can take place. The document(s) will be copied and the copy retained by the licensing authority. The original document will be returned to you. If there are restrictions on the length of time you may work in the UK, your licence will not be issued for any longer than this period. In such circumstances, the check will be repeated each time you apply to renew or extend your licence. If, during this period, you are disqualified from holding a licence because you have not complied with the UK's immigration laws, your licence will lapse and you must return it to the licensing authority, failure to do so is a criminal offence.
