Item 1 – WELCOME & APOLOGIES	
CF welcomed forum & read out apologies.	
All members, observers and advisors introduced themselves & their access interests/role.	
Items 2 & 3 – ACCESS MANAGEMENT PRESENTATIONS	
OUTDOOR RECREATION	
NT presented CCC Outdoor Recreation management. An outline of the Outdoor Recreation portfolio, how it is managed and maintained & the challenges. Follow up Q&A.	
COMMON LAND	
AP presented a summary of CCC Common Land management and its challenges. The process of digitising the Common Land register was also detailed including future consultation which the LAF can be included in. Follow up Q&A.	
MH thanked both presenters and encouraged continued engagement with both services going forward.	
CF explained that one further session of Access presentations is scheduled for the third meeting of the new LAF term. NRW, Sustrans and CCC Grounds Maintenance will present a summary of access management within their remit.

Item 4 – ELECTION OF LAF CHAIR & DEPUTY CHAIR

MH accepted role as Chair and led remainder of meeting.

<u>Item 5 – PROW PROJECTS UPDATE</u>

AM provided an update on all current projects, outlining planning and progress in each case.

Successful funding bids also detailed including where funding is to be spent.

KB requested that a map of project areas be provided from next meeting to help understand the overall picture of PROW network improvement.

Query regarding Volunteer Surveying project, will it continue after 2 years?

CF advised that a commercial solution to complete the surveys may be sought from 1 April 2026 to keep the data collection across a 3-year period or less, retaining validity of all data gathered. Volunteers will be moved to new roles.

RL - the volunteer project is a model for the future

AM - some volunteers may wish to continue surveying beyond 31 March 2026, they will be accommodated but many have expressed more interest in doing more physical work such as clearing paths and/or helping with furniture installation

<u>Item 6 – PUBLIC RIGHTS OF WAY PERFORMANCE REPORTS</u>

All members reviewed reports ahead of meeting

CF Apology – Freedom of Information Requests, Searches & Complaints data omitted.

RL suggested that the reports are produced quarterly according to calendar year regardless of when LAF meetings fall to make comparisons easier.

Also, need to ensure a read across the reports to ensure numbers of active items at the end of one period equate to the backlog at the beginning of the next - inconsistencies have been noted.

Also expressed opinion that data should be presented to improve understanding of legal matters caused by obstructive landowners.

Members agreed.

CF to consider suggestions ad discuss report alterations with software provider.

Proper analysis of data to begin once a full year of new reports have been produced.

MH agreed plans should contain more positive goals in respect of access.

- Include recreational vehicular access considerations
