

**ROAD TRAFFIC REGULATION ACT 1984**

**(TEMPORARY RESTRICTIONS) ACT 1991**

**THE COUNTY OF CARMARTHENSHIRE (SPECIAL EVENTS) (BRITISH SUPER  
TRIATHLON AND PARATRIATHLON SERIES)  
(TEMPORARY TRAFFIC MANAGEMENT) ORDER 2025**

---

**WHEREAS** the roads specified in the Schedule to this Order form the area designated to be used as the route to enable the 'British Super Triathlon and Paratriathlon Series' to take place ('the Event').

**The** Carmarthenshire County Council (hereinafter referred to as "the Council") is the Highway Authority for those lengths of road more particularly referred to in Part I and Part II of the Schedule to this Order.

**The** organisers of the Event wish to prohibit the use of the lengths of road described in Part I and Part II of the said Schedule by vehicles and unauthorised bicycles on Saturday 10<sup>th</sup> May, 2025 between the hours of 6.00 a.m. and 9.00 p.m. for the holding of the Event and again on Sunday 11<sup>th</sup> May, 2025 in relation to the length of specified in Part II of the Schedule between the hours of 6.00 a.m. and 1.00 p.m.

**The** Council is satisfied that vehicles and unauthorised bicycles on the said lengths of road should be prohibited for the purpose of facilitating the holding of the Event.

**NOW** therefore the Council in pursuance of their powers under Section 16(A) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby make the following Order:-

1. That the roads more particularly described in Part I and Part II of the Schedule to this Order shall be used to hold the Event on Saturday 10<sup>th</sup> May, 2025 between the hours of 6.00 a.m. and 9.00 p.m.

2. That the road more particularly described in Part II of the Schedule to this Order shall be used to hold the Event on Sunday 11<sup>th</sup> May, 2025 between the hours of 6.00 a.m. and 1.00 p.m.
3. Save as provided in Article 4 of this Order no person shall cause or permit any motor vehicle including any unauthorised bicycles to proceed:
  - (a) along those lengths of road listed in Part I and Part II the Schedule to this Order between the hours of 6.00 a.m. and 9.00 p.m. on Saturday 10<sup>th</sup> May, 2025, and
  - (b) along that length of road listed in Part II the Schedule between the hours of 6.00 a.m. and 1.00 p.m. on Sunday 11<sup>th</sup> May, 2025.
4. Nothing in Article 3 of this Order will:
  - a) have the effect of preventing at any time access for pedestrians to premises situated on or adjacent to any of the roads to which the Order relates or to any premises only accessible to pedestrians from such road,
  - b) apply to any motor vehicle being used for police, fire brigade or ambulance purposes or the purpose of a statutory undertaker or local authority attending an emergency,
  - c) apply to anything done with the permission or at the direction of a police constable in uniform, and
  - d) apply to any motor vehicle being used in connection with the Event
5. This Order shall come into operation on Saturday 10<sup>th</sup> May, 2025 between the hours of 6.00 a.m. and 9.00 p.m. and shall continue on Sunday 11<sup>th</sup> May, 2024 between the hours of 6.00 a.m. and 1.00 p.m. and may be cited as The County of Carmarthenshire (Special Events) British Super Triathlon and Paratriathlon Series) Temporary Traffic Management) Order 2025

## **SCHEDULE**

### **Part I**


1. That length of the Class II Road B4304 extending from Lledi Roundabout in a general south easterly direction to its junction with Delta Lakes Roundabout.
2. That length of road known as Copperhouse Road extending from Copperhouse Roundabout to its junction with Northumberland Road.
3. That length of road known as Northumberland Road from its junction with Copperhouse Road to its junction with The Avenue

### **Part II**

1. That length of road known as Traeth Ffordd at North Dock from a point 80 metres west of its junction with Lledi Roundabout for a distance of 140 metres in a westerly direction
