ORDER UNDER SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847

FOR THE PREVENTION OF OBSTRUCTION

On Saturday 22nd November 2025, for the Carmarthen Christmas Light Switch on the following streets will be thronged and liable for obstruction for their entire length Guildhall Square, Queen Street, King Street, Bridge Street, Little Bridge Street, St Marys Street, Quay Street and Nott Square, Carmarthen between the hours of 08:00 hours and 18:00 hours.

The CARMARTHENSHIRE COUNTY COUNCIL pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847 DOES HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the said streets ,Guildhall Square, Queen Street, King Street, Bridge Street, Little Bridge Street, St Marys Street, Quay Street and Nott Square, Carmarthen shall be closed to all vehicular traffic including pedal cycles between the hours indicated above on Saturday 22nd November 2025 subject to emergency service vehicles being allowed access to the street without delay in the event of an emergency.

There is no alternative route for St. Peters Street, King Street, Queen Street, Guildhall Square, Hall Street, and Nott Square but access will be maintained for emergency services
