# Fframwaith Agored | Open Framework

**Mae Fframwaith Agored yn gynllun o fframweithiau sy'n darparu hyblygrwydd trwy benodi Cyflenwyr newydd yn ystod oes y cynllun Fframwaith.**

An Open Framework is a scheme of frameworks that provides flexibility by appointing new Suppliers during the life of the Framework scheme.

**Gall bara hyd at uchafswm o 8 mlynedd**

It can last up to a maximum of 8 years

**Gellir ei ailagor unwaith yn ystod y cyfnod o dair blynedd ar ôl dyfarnu'r fframwaith cyntaf ac o fewn 5 mlynedd gan ddechrau ar ddyfarnu'r ail fframwaith yn y cynllun.**

Can be re-opened once during the period of three years from award of the first framework and within 5 years beginning on the award of the 2<sup>nd</sup> framework in the scheme.

When using colour, we should think about what mood we want our service users to feel. Campaign materials should use the more vibrant colours of the accent palette, whilst for our corporate work we'll be using a more limited but unique palette

Our identity system has a broad range of colours although this doesn't mean we have to use all of them at the same time! Choosing a single colour, or a pair of colours, for a campaign

brings unity and coherence to our work. In any event, we never use more than three colours in combination.

Always ensure you have selected the correct PMS colour or colour breakdown for the stock you are printing on. Paper applications use Pantone and CMYK references. Screen applications use RGB breakdowns and web applications use HTML codes.
