

THE COUNTY OF CARMARTHENSHIRE
(GATE ROAD, PENYGROES AND BLACK LION ROAD, GORSLAS)
(EXPERIMENTAL 7.5 TONNE WEIGHT RESTRICTION) ORDER 2025

CARMARTHENSHIRE COUNTY COUNCIL (hereinafter referred to as “the Council”), in exercise of its powers under Section 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, shall hereby make the following Order:-


1. This Order may be cited as “The County of Carmarthenshire (Gate Road, Penygroes and Black Lion Road, Gorslas) (Experimental 7.5 Tonne Weight Restriction) Order 2025” and shall come into operation on the Tenth day of March, Two Thousand and Twenty-Five.
2. In this Order, “goods vehicle” shall have the same meaning as in the Roads Vehicles (Construction and Use) Regulations 1986.
3. Save as provided in Article 4 of this Order, no person shall cause or permit any goods vehicle, whose maximum gross weight exceeds 7.5 tonnes, to enter or proceed in the lengths of road specified in the Schedule to this Order.
4. Nothing in Article 3 of this Order shall prevent any person from causing or permitting any goods vehicle to enter or proceed in the lengths of road referred to therein if the vehicle is being used:
 - (a) for the conveyance of goods or merchandise to or from any premises situated on or adjacent to the said roads;
 - (b) in connection with the carrying out, on premises situated on or adjacent to the road, of any of the following activities:
 - (i) building, industrial or demolition operations;
 - (ii) the removal of obstructions to traffic;
 - (iii) the maintenance, improvement or reconstruction of the road;
 - (iv) the laying, erection, alteration or repair of any sewer, main, pipe or apparatus on land or land adjacent to the road, for the supply of

water, gas or electricity, or any telegraphic line (as defined in the Telecommunications Act 1984);

- (c) in the service of a local authority, environment agency or water or sewerage undertaker in pursuance of statutory powers or duties;
- (d) to access premises or land on or adjacent to the said lengths of road;
- (e) for agricultural purposes; and
- (f) in accordance with directions given by a police constable in uniform.

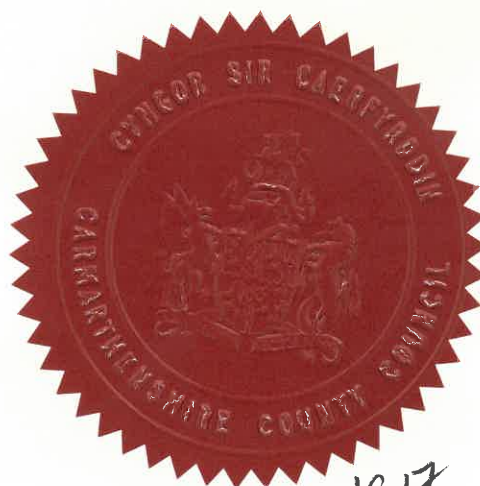

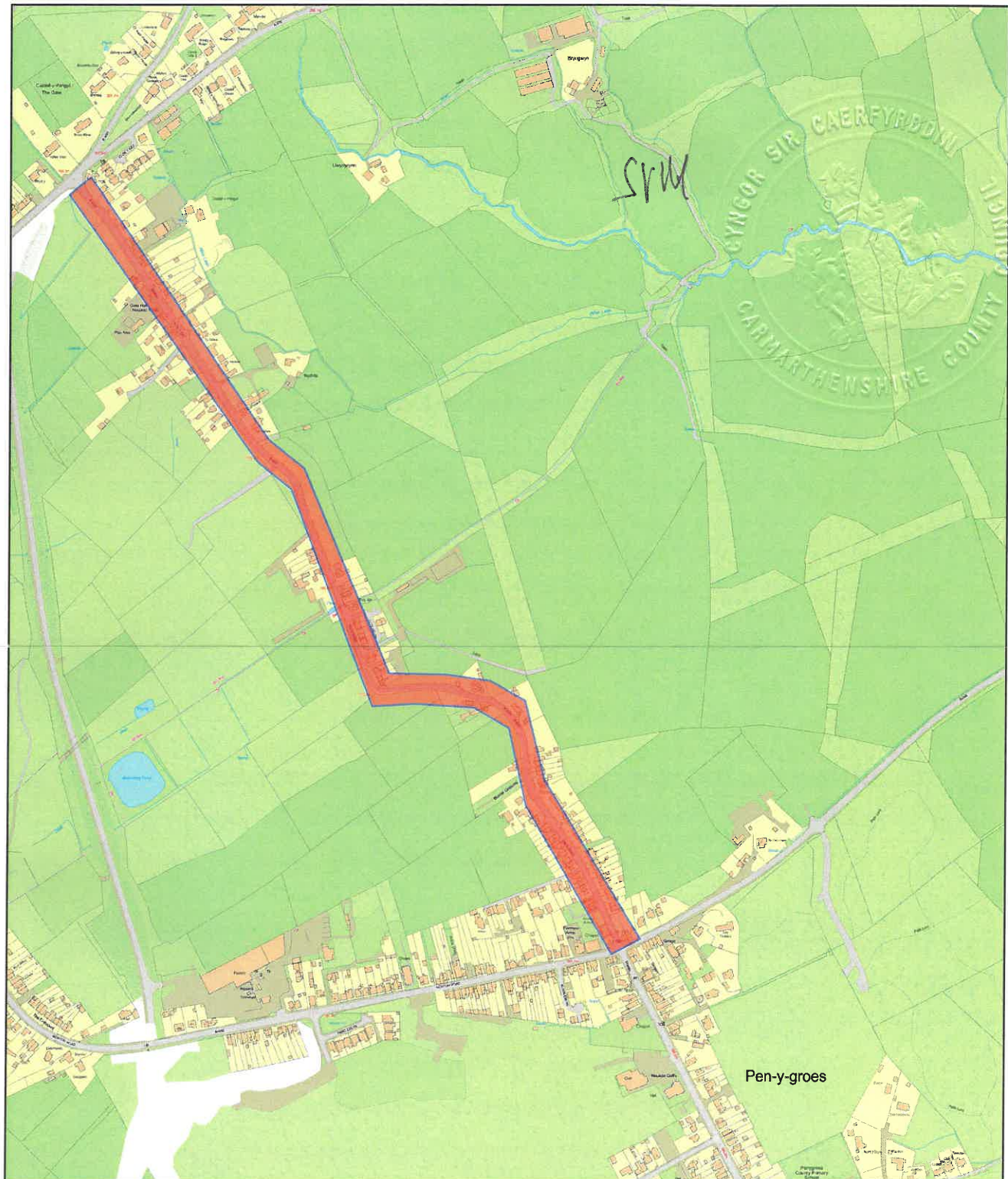
