## <u>THE COUNTY OF CARMARTHENSHIRE (CARMARTHEN)</u> (WAITING RESTRICTION AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NUMBER 23) ORDER 2024

The Carmarthenshire County Council in exercise of their powers under Sections 1(1), 2(1) to 2(3), 4(2), 32, 35 and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984 (which said Act is hereinafter referred to as "the Act of 1984") (as amended) and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order:-

  - b. The County of Carmarthenshire (Carmarthen) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 and The County of Carmarthenshire (Carmarthen) (Waiting Restrictions and Street Parking Places) Consolidation (Variation No. 2) Order 2004 are hereby revoked insofar as the same relate to the restrictions briefly described in Schedules 1, 2, 3 and 4 to this Order and more particularly shown on the plans bearing the unique reference numbers specified in column 3 of the said Schedules.
