

**THE COUNTY OF CARMARTHENSHIRE**  
**(PUBLIC FOOTPATHS 36/114 (PART) AND 36/115 (PART) LLWYNHENDY,**  
**LLANELLI) TEMPORARY PROHIBITION OF PEDESTRIAN TRAFFIC ORDER**  
**2025**

**WHEREAS** the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for those lengths of footpaths:

- a. numbered 36/114 extending from the cul de sac northwest of Number 3 Clos Y Berllan, Llwynhendy for a distance of approximately one hundred and eleven (111) metres in a north-easterly direction and then veering in a north westerly direction through a housing development to the northwest boundary of that same development; and
- b. numbered 36/115 extending from Llys Pendderi, Llanelli in a general north westerly direction along a route adjacent to the northeastern boundary of Number 1 Llys Pendderi before veering in a south westerly direction along the rear boundary of the said property and thereafter continuing in a north westerly direction to its junction with footpath 36/114

are satisfied that pedestrian traffic in the said lengths of footpaths should be restricted by reason of the development works being undertaken on land accommodating each length of footpath.

**NOW** therefore the Council in exercise of their powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby make the following Order:-

1. No person shall proceed along:
  - a) That length of Footpath numbered 36/114 extending from the cul de sac northwest of Number 3 Clos Y Berllan, Llwynhendy for a distance of approximately one hundred and eleven (111) metres in a north-easterly direction and then veering in a north westerly direction through a housing development to the northwest boundary of that same development; and

b) That length of Footpath numbered 36/115 extending from Llys Pendderi, Llanelli in a general north westerly direction along a route adjacent to the north eastern boundary of Number 1 Llys Pendderi before veering in a south westerly direction along the rear boundary thereof before continuing again in a north westerly direction to its junction with footpath 36/114

2. This Order shall come into operation on the twentieth day of June Two Thousand and Twenty Five and may be cited as The County of Carmarthenshire (Public Footpaths 36/114 (Part) and 36/115 (Part) Llwynhendy, Llanelli) Temporary Prohibition of Pedestrian Traffic Order 2025
