ORDER UNDER SECTION 21 OF THE TOWN POLICE CLAUSES ACT 1847

FOR THE PREVENTION OF OBSTRUCTION

Whereas the roads in Llandovery as specified in the Schedule to this Order will be thronged and liable to be obstructed on Saturday 19th September 2026 from 08:00 hours to 20:00 hours for Llandovery Sheep Festival.

The CARMARTHENSHIRE COUNTY COUNCIL pursuant to powers conferred by Section 21 of the Town Police Clauses Act 1847 DOES HEREBY ORDER AND DIRECT that for the purpose of preventing obstruction in the streets as listed in the Schedule, the said streets shall be closed to all vehicular traffic including pedal cycles between the hours of 08:00 hours to 20:00 hours on Saturday 19th September 2026 subject to emergency service vehicles being used for police, fire brigade or ambulance purposes or the purpose of a statutory undertaker or local authority attending an emergency being allowed access to the said streets without delay in the event of an emergency.

The alternative route to access Victoria Crescent and Maes Glas for vehicles not exceeding 7.5 Tonne is to proceed via the TR A40, TR A483 and B4344 Stone Street. No Access permitted for vehicles exceeding 7.5 Tonne.

1. Market Square, Llandovery from its junction with Broad Street to its junction with Stone Street
2. Stone Street from its junction with the TR A40 to its junction with Victoria Street
