# THE COUNTY OF CARMARTHENSHIRE (LLANELLI) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NUMBER 44) ORDER 2025

The Carmarthenshire County Council (hereinafter referred to as "the Council"), in exercise of the powers conferred by Sections 1(1), 2(1) to 2(3), 4, 32(1), 35 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004 and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

- 1. "The County of Carmarthenshire (Llanelli) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004" ("the Consolidation Order"), as subsequently varied, is hereby modified by the substitution of the plans appended thereto for the plans appended to this Order, which has the effect of imposing, along the lengths and sides of the roads identified and for the periods identified in Schedule 1 to this Order, a prohibition on parking at any time, except for disabled persons' vehicles parked in the position specified in the said Schedule and displaying a valid disabled person's badge, parking disc or other permit issued by the Council, in the relevant position and in all other respects, in accordance with the Consolidation Order.
- 2. The Consolidation Order and "The County of Carmarthenshire (Llanelli) (Waiting Restriction and Street Parking Places) Consolidation (Variation No.38) Order 2020" are hereby revoked insofar as they relate to the sides of road shown in Schedule 2 to this Order.

The Order shall come into operation on the \*\*\* day of \*\*\* 2026 and shall be cited as "The County of Carmarthenshire (Llanelli) (Waiting Restrictions and Street Parking Places) Consolidation (Variation Number 44) Order 2025".
