TEMPORARY PROHIBITION OF PEDESTRIAN TRAFFIC ORDER 2025

WHEREAS the Carmarthenshire County Council (hereinafter referred to as "the Council") being the Highway Authority for that length of Footpaths Number 33/22 (Part) & 59/53 (Part) specified in Column 1 of the Schedule to this Notice.

NOW therefore the Council in exercise of their powers under Section 14(2) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers hereby make the following Order:-

1. No Pedestrians shall proceed along that length of Footpaths Number 33/22 (Part) & 59/53 (Part) specified in Column 1 of the Schedule to this Notice.
2. This Order shall come into operation on the 18th December, 2025 and may be cited as The County of Carmarthenshire (Public Footpaths Number 33/22 (Part) & 59/53 (Part), Tumble) Temporary Prohibition of Pedestrians Traffic Order 2025

Public footpaths 33/22 (Part) & 59/53 (Part)	From a point on Ty Isha Road at Ordnance Survey Grid Reference (OSGR) SN53681152, heading in a generally south-westerly direction along the lengths of footpaths 33/22 (Part) & 59/53 (Part) and the cycleway to a junction with footpaths 33/66 & 59/50, south of Coed Mawr at OSGS SN51501025. Length: 2867 metres
