CONSTRUCTION OF NEW ROAD HUMPS - VARIOUS ROADS, LLANELLI

NOTICE IS HEREBY GIVEN that Carmarthenshire County Council ('the Council'), in exercise of the powers conferred by Section 90A of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers, and after consultation with the Chief Officer of Police and those bodies or persons prescribed by the Highways (Road Humps) Regulations 1999 (hereinafter called 'the Regulations') in accordance with Section 90C(1) of the Act, and in accordance with Section 90C(2) of the Act, intends to construct road humps in the form of a raised plateau, in compliance with the Regulations, along various roads in Llanelli.

The locations of the road humps are more particularly described in the Schedule, and shown on the plans annexed, to this Notice.

The proposed road humps will extend across the full width of the carriageway and will be in the form of a raised plateau, with the plateau measuring either 3000 millimetres (3 metres), 4000 millimetres (4 metres) or 6000 millimetres (6 metres) in length. Each road hump will measure 75 millimetres in height, in line with the tolerances permitted in the Regulations (where a hump should not exceed 100 millimetres in maximum height).

Full details of the proposal, together with plans and a statement of the Council's reasons for seeking to introduce these vertical measures, may be examined at the offices of the Council's Customer Service HWB at No.36, Stepney Street, Llanelli SA15 3TR during the usual office hours.

- 3. Northumberland Road, Llanelli Centred at a location approximately 61 metres west of its junction with the B4304, The Avenue.
